The rules of the K-Classic Competition

Article 1.

Korean American Cultural Foundation organizes The K-Classic Competition.

Article 2.

The competition is open to all 'non-Korean' personals who are over 18 years old and living in the United States of America.

Article 3.

Participants should perform 2 Korean art songs. One from Category I, and the another from Category II. The lists of songs and scores are available at the website: www.KACFoundation/competition

Each song should be performed in Korean language, and participants can change the key as he/she wants to perform.

The contestants should upload their video to Youtube, and must provide the youtube link on the application form.

Article 4.

The contestants will be judged based on the submitted recordings(youtube link) to be qualified as winner(s). All winners will be invited to the Master Class with Professor ChungHwa Lim from K-Classic Globalization Foundation, South Korea. The Master Class' date, time, and place will be announced later.

Article 5.

Videos should be recorded no more than 6 months before the date of your submission.

When you submit YouTube links, be sure your videos have the proper settings: VIDEO MANAGER → videos → Basic Info → from the dropdown menu, please choose "Public" or "Unlisted" instead of "Private".

Article 6.

Registration is to be done exclusively through electronic means. Entering the website to download the application form. Fill out the form and send it us to the following email address: director.kacf@gmail.com

Article 7.

A minimum of Three qualified judges will be evaluating the audition materials. All Jury decisions are final and irrevocable.

Article 8.

The winners will be awarded with \$1,000 of cash prize and an enormous opportunity of performance at Gas South Theater with Atlanta Sinfonia as a main program of "K-Classic Concert".

Article 9.

By applying to the competition, participants automatically accept conditions from previous provisions of the online music competition rules.
